We respectfully request that all returning nippers, their parents and patrolling members register before the start of the patrol season.



Every person who has ever been a member of SLSA is listed in Surfguard, please do not make another account. If you cannot get access to your members area, contact our registrar and he will help you out.

No membership application can be approved without payment through the portal, if you need help contact our registrar.

Further step-by-step instructions on how to use the portal can be found below.

The 2023/24 fee structure is outlined below.

- Individual Membership (Patrolling Members) \$60

- Associate (1 parent must be registered with their child) \$70
- Family Membership \$200

There will be a fee increase from October 2nd.

- Associate (1 parent must be registered with their child) \$75
- Family Membership \$220

New Members – Welcome!

New members can also use the members portal to register (use the same link above). You can create your own account, register, and pay your membership fee all online. Please do liaise with our registrar prior to this so you can determine the costs and for new nippers send through copies of your child's birth certificate and parents driver's license. The originals will need to be sighted on the first day of nippers. All nippers must have an adult join with them as an associate member.

Active Kids Vouchers

Fingal Beach has registered for the Active Kids initiative and can accept the Active Kids vouchers issued by Service NSW. Please see instructions below as Active Kids Vouchers can only be used with individual memberships.

Working with Children Check

We encourage every member over the age of 18 to obtain and supply the club with a Working with Children check number.

Identification

All new nippers/members must supply their birth certificate/driver's license/identification to either the Registrar or Secretary. We will be available on the first 2 weeks of nippers to visually check the originals against the copies that we have been sent previously. Please ensure that you bring them with you.

Junior Carnival Packs

There will be no Junior Carnival Packs for purchase this season.

Registration and payment for individual carnivals will be taken TWO weeks prior to each carnival on the regular Sunday morning Nipper days. Costs for each carnival will be advised prior to this.


We have been advised that each Surf Lifesaving Club that enters competitors into carnivals is required to supply a certain number of water safety and officials in relation to competitor numbers. This is a requirement that we have struggled to meet in the past. If you would be interested in obtaining your Officials or Bronze Medallion qualification so that you can help out at these events it would be greatly appreciated. Please note: Nippers must have competed in 75% of the Hunter Branch carnivals to compete at the State Age Carnival, there are no exceptions to this rule.


If you have a family group, click on the family group renewal, if your family members are already linked you can register everybody in one go or you can create your family group

from members already in the system.

Note: Due to recent upgrades of the members portal, family membership does not recognise the Active Kids vouchers. If you would like to use these, you will need to register your children individually and use the Active Kids Voucher that corresponds to each child's name to the value of \$60. This means that you will only need to pay the \$10. Parents will then also need to register individually.



Next: Click on renew memberships in blue on the right-hand side of the screen. It will take you to the below.

There is an arrow in the box below each family members name. For a family membership select the \$200 family group under the primary family members name and select \$0.00 included in family group for the other family members and click next.

You will then be taken to the addon fees page. The only addon fees we have is for a gym membership. If you are planning to join the gym, there are 2 fee structures \$55 for patrolling members and \$330 for associate members. You don't have to join the gym through the portal. Payment can also be made through the link provided on our website https://www.fingalbeachslsc.com/home do please visit this for more information prior to paying for a membership.

If you do not wish to include an addon payment, click next. This will take you to the summary page for your membership. Please check that everybody in your family is included and the correct amount is listed against the total.

Check the application and declaration box, acknowledging you have read and understood the declaration. Complete your name and click next. The next page requires you to make payment to finalise the application. Check your details are correct and follow the prompts to make your payment.

Individual Registrations

If you are registering individually, you can click on individual renewal. This will take you straight to a page where you can check that all your details (personal information etc) are correct.
